**The murdering of Children – Full Term Abortions**

## The Moral Dilemma of Vaccination Technology

**The logical argument:**

## The Philosophical Dilemma of Vaccination Technology

The Judeo/Christian worldview is based on a “**Verification Principle**”. That is, every truth claim in the Bible is not to be taken on face value, it is to be tested, evaluated, verified – then believed.

**Example** is the claim of Jesus Christ to be God in human form. This claim was not to be accepted because He only *claimed* to be the Son of God. It was to be accepted because he ‘*proved*’ it to be so through His many miracles that only God could do.

**John 10:37–38** *“If I do not do the works of My Father, do not believe Me; but if I do, **though you do not believe Me, believe the works**, that you may know and believe that the Father is in Me, and I in Him.”*

**Acts 1:3** *“to whom He also presented Himself alive after His suffering by **many infallible proofs**, being seen by them forty days...”*

The Dilemma occurs when we are told to “accept” the safety of vaccine ingredients when these vaccine ingredients have not been verified as safe. In the scientific community one can verify a truth claim by using the Scientific Method.

**The scientific method is:**

1. **Question! Question! Question! --- Think! Think! Think!**

2. **Observation:**

3. **Hypothesis:** a proposed explanation that can be verified through testing.

4. **Experimentation** to either verify or falsify the hypothesis

5. **Conclude** with a **Theory**; a theory is an explanation that can be repeatedly tested and verified in accordance with accepted protocols of observation, measurement, and evaluation of results. Theories are tested under controlled conditions in an experiment.

The safety of Vaccine ingredients has not been verified through the scientific method.

The Christian worldview does not accept “*truth claims*” unless it can be substantiated and verified through rigorous testing methods which is done through Double Blind Crossover Placebo Control group tests. Pharmaceutical companies have not done this. How do we know? READ THE VACCINE INSERTS! It says how long the tests were conducted which are all short term.
